Amend Article XVII - (e) MINIMUM REQUIREMENTS by striking and replacing.

(10) Any Post owning property and/or operating any facility or business concern must maintain general liability insurance, including, if necessary or appropriate, liquor liability insurance in an amount of one million dollars (\$1,000,000.00). Such insurance must name, as additional insured's, the "National Veterans of Foreign Wars of the United States" and the "Department of Texas Veterans of Foreign Wars of the United States".

Any Post owning and/or operating, directly or by reason of a holding company or other entity substantially controlled by the Post, or its members, a canteen, clubroom, or other facility available to members or guests must maintain general liability insurance, including, if necessary or appropriate, liquor liability insurance. Such insurance must be of a type and amount sufficient to protect the Post, and must name, as additional insureds, the Veterans of Foreign Wars of the United States, and the Department in which such Post is located. Submit to the Department Adjutant a copy of this insurance by December 31st of each year. It is desirable that Posts not owning property have the same coverage in the event of injury at a Post sponsored activity as a subsequent lawsuit may subject all assets of the Post and each individual member to a court ordered judgment.
