17. Posts are reminded of the provisions of Section 214-Solicitation of Funds:

Commanders at all levels must review and understand the provisions of Section 214, Solicitation of Funds, of the 2023 National VFW Bylaws. "Fundraising organizations or individuals conducting solicitations, activities or projects for a profit shall not be engaged or used by any Post for such purpose unless such engagement is made by written agreement between the Post and the organization or individual's providing those services. The form of any such written agreement must be submitted to the Department Commander for review and approval at least thirty (30) days prior to any Post entering into any such agreement."

Any Post fundraising that requires an agreement with a vendor must be approved by State Commander Larry Sanders and the document must be submitted to the Department of Texas VFW Headquarters office for filing.

18. Emergency Funds for Maui Wildfire Disaster:

It is with great enthusiasm that we can report the results of the electronic vote by the Department of Texas VFW Council of Administration which unanimously approved to provide Emergency Disaster Relief funds in the amount of \$10,000.00 to support the Department of Hawaii VFW.

This disaster has affected so many people there and many of them are veterans and their families. VFW National offered to match any funds sent by Departments up to \$30,000.00 which means that our \$10,000.00 is now \$20,000.00!
